Victorian COVID-19 Report Update



The number of people in hospital with COVID-19 has decreased since the 17 December 2024 from 160 to 151 per day on average.

These are the steps you can take to help protect yourself from COVID-19 if you and/or your family members are at risk.

- 1. Stay at home if you are unwell with symptoms of cold or flu. Speak to your GP, if your symptoms get worse
- 2. Test if you have symptoms take a rapid antigen test (RAT).
- 3. If you test positive and are eligible for antivirals, take them as soon as possible.
- 4. You should stay at home until you have no symptoms. Avoid group settings outside your family for 7 days.

- 5. Get vaccinated: stay up to date with your COVID-19 vaccine to help protect you from becoming very sick.
- 6. Get a booster if you are over 75 and haven't had one for 6 months.
- 7. Boosters are free and are available from your GP or local pharmacy.
- 8. Wear a mask, especially if you have symptoms or are visiting others to protect you and others from the virus.
- 9. Let fresh air in by opening windows and doors when you can it reduces the spread of the virus. Meet outside when possible.
- 10. Take antivirals to stop you from getting so sick that you need to go to hospital. See your GP for more information about getting antivirals. You must take these within 5 days of developing symptoms - the sooner the better.

- 3. Work with our Systems Development Project Officer to research the data needed to help establish a Social Enterprise which trains and certifies providers needing and wanting to make their services accessible to people with disabilities.

CHIEF EXECUTIVE OFFICER REPORT



Funding for 2025

We are funded by the Commonwealth Department of Social Services (DSS) until the 30 June 2025 for:

- Disability Advocacy (Individual, Legal and Systemic), and
- NDIS Appeals Support to lodge applications to overturn decisions by the NDIA in the new Administrative Review Tribunal (ART). See <u>https://www.art.gov.au/applyingreview/national-disability-insurance-scheme</u>.

However, with the loss of the Disability Royal Commission funding we have 64 less hours per week of funding for Disability Advocates with legal backgrounds and experience at the 01 January 2025.

NDIS APPEALS

We provide support to Participants in the Melbourne Metropolitan area which covers over 3.6 million people.

We can help Participants who want to appeal a decision by the National Disability Insurance Agency to the Administrative Review Tribunal (ART) Our Waiting list for this is closed temporarily until further notice whilst we recruit some Disability Advocates for the new year.

DISABILITY ADVOCACY

Our disability advocacy service is funded under the National Disability Advocacy Program (NDAP).



Our Waiting List for NDAP advocacy re-opens on the 02 January 2025 - but not for any NDIS Appeals matters outside the Administrative Review Tribunal (ART). For example, if you have been rejected as a NDIS Participant and need help to appeal this decision internally with the NDIA, then we will help you find another service that can support you.

We provide Individual and Legal Advocacy (70%) and Systemic Advocacy (30%) support to people who live in metropolitan Melbourne and have:

- 1. Disability which is permanent or likely to be permanent; and 2.
 - A substantially reduced capacity for:
 - Communication (writing, typing or speaking) OR
 - Learning
 - Mobility; and
- A need for ongoing support services 3.

OUR REVISED NATIONAL CONSTITUTION

This came into effect in September 2021 and a copy is available on our website: https://dia.org.au/membership/our-constitution/#constitution.

We can legally operate as a national cross disability organisation and retain our charitable status with the Australian Taxation Office (ATO), the Australian Charities and Not-for-profit Commission (ACNC) and the Australian Securities and Investment Commission (ASIC).

OR

Our Objectives are

- (a) To provide a range of services that are responsive to the needs of people with disabilities and their families.
- (b) To promote and protect the human rights of people with disabilities; and
- (c) To provide advocacy and support services to facilitate and support the achievement of the above objectives.

The revised Constitution was passed by a record of **87.1%** of all members present and eligible to vote at a Special General Meeting on the 23 September 2021.

NEW DJA MEMBERSHIP CATEGORIES

We have members in all states and territories and have been inviting all to renew or join under one of the following new categories which were introduced with our Revised Constitution.

FULL MEMBERSHIP: This is for people with disability over 18 who have a vote at any DJA meeting and can nominate for election to the Board.

INDIVIDUAL MEMBERSHIP: This is for a parent, carer, informal support person, or guardian over 18 of a person with a Disability (of any age) where the person with the Disability you support does not have Full Membership of Disability Justice Australia themselves. They have a vote at any DJA meeting and may be invited to join the Board

ASSOCIATE MEMBERSHIP: This is for any organisation or its representative that is not eligible for Full Membership. There are two types: Charitable and Corporate. They are not entitled to vote at DJA meetings.

- Future members will receive a personalised membership card which will give them access to membership benefits on our website.
- Full members may get travel subsidies to attend DJA events.
